I understand and agree that I participate in the Event at my own risk.

I acknowledge the Event may involve a significant degree of physical exertion and the risk of physical injury and accept that Cancer Council Queensland has undertaken no assessment of my ability to participate and I am solely responsible for my own level of fitness and personal ability to participate.

I am aware of the risks involved in participation in the Event including the risk of physical injury and voluntarily agree to assume those risks.

I agree to consult with my medical practitioner prior to the Event if I am in any doubt as to my fitness and whether to participate.
